


Fig.1 Switching test circuit




Fig.2 Definition of stray inductance





Fig.3 Definition of switching loss







Forward Voltage of diode




Recovery loss vs. Forward current




Reverse Recovery time vs. Forward Current



Reverse Recovery loss vs. Gate Resistance






